IMPORTANT NOTICE: REGULATORY REQUIREMENTS

- Only triple rinsed and punctured empty pesticide packaging may be recovered, transported and recycled (**except PET (code 1) pesticide containers which cannot be recycled but must be incinerated even if they are triple rinsed**). Such packaging **IS NOT CLASSIFIED AS DANGEROUS GOODS** by the SA National Standard 10406:2014 **Clause 3.1.6** but is classified as nominally empty packaging:

- nominally empty packaging:**

Previously certified packaging from which contents have been removed as far as possible, by means of the practices commonly employed to remove materials from that type of container, for example pouring, scraping, pumping, or aspirating

NOTE: Packaging containing residual material of division 6.1 (main or subsidiary hazard, in accordance with SANS 10228) is not deemed empty unless it has been triple-rinsed with an effective solvent, or has been cleaned by a method proved to achieve equivalent removal (triple rinsing in the case of empty pesticide packaging or as directed otherwise by the CropLife SA guidelines)

- Packaging that is contaminated with pesticides is categorised as hazardous waste and dangerous goods, and must be treated as such, meaning transported ONLY according to SANS10231 with vehicles licensed as dangerous goods vehicles (D,G license disc), fitted with the required dangerous goods identification placards and driven by drivers that are qualified and licensed to drive dangerous goods vehicles.
- Even if packaging is properly rinsed, re-using, selling or donating them as packaging or containers for any other purposes is unlawful.
- Nominally empty or contaminated empty packaging may not be buried or burned on the farm; it is criminal offense in terms of the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008) and a terrible waste of a valuable resource to burn or bury empty packaging on the farm.
- Farmers must insist on being issued with a CropLife SA CoDi Intel Declaration by the recycler every time they hand nominally empty packaging over to a CropLife SA certified recycler.

IMPORTANT NOTICE ABOUT UNRINSED CONTAINERS

CROPLIFE SOUTH AFRICA AND ITS CERTIFIED RECYCLERS WILL NOT COLLECT OR RECEIVE ANY PESTICIDE CONTAINERS THAT ARE NOT FULLY TRIPLE RINSED (FOR SOLID PACKAGING AND SPRAY RINSED FOR FLEXIBLE PACKAGING). SUCH CONTAINERS ARE CLASSIFIED AS HAZARDOUS WASTE AND MAY ONLY BE HANDLED AND TRANSPORTED BY COMPANIES THAT ARE LICENSED TO HANDLE AND TRANSPORT HAZARDOUS WASTE. CONTAINERS THAT ARE NOT TRIPLE RINSED TO THE SATISFACTION OF RECYCLERS WILL BE RECORDED AS SUCH AND LEFT TO THE OWNERS THEREOF WHO SHALL CONTRACT HAZARDOUS WASTE DISPOSAL SERVICE PROVIDERS TO COLLECT AND DISPOSE OF SUCH CONTAINERS AT THE EXPENSE OF THEIR OWNERS.

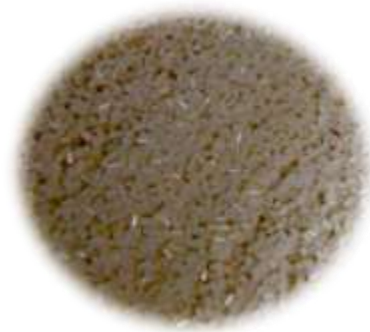


USING PESTICIDE PACKAGING POST-CONSUMER RECYCLATE (PCR) FOR MANUFACTURING POLYMER GOODS

• HDPE, LPDE and PP pesticide packaging materials that have been processed by triple rinsing, shredding, high temperature washing, melting, blending with stabilisers, melting and extruding into pellets (also known as post-consumer recycle or PCR), have been analysed locally and internationally for traces of pesticide residues. Analyses have shown no pesticides are present at detectable levels. This means that the pesticide packaging PCR is free from pesticide residues.

• Pesticide PCR is used in the manufacturing of various items, including but not limited to -

- New pesticide containers (anything from 30 to 100% PCR)
- Irrigation pipes
- Fencing posts and droppers
- Pallets
- Refuse bags
- Plastic decking planks
- Crates
- Small stock mobile kraals
- Plastic outdoor furniture



• **Pesticide PCR is NOT used to manufacture packaging for any food grade materials or beverages**

Triple rinsing as instructed removes 99.9% of pesticide residues from containers. This is confirmed by chemical analyses conducted by the CropLife SA PRO that showed plastic chips coming from empty, triple rinsed pesticide containers contain at worst only 0.000375% pesticide residues or 3.75 mg/kg pesticide residues in the plastic

REMOVE INSERTS AND RUBBER SEALS FROM CAPS, AND REMOVE SPRAY HEADS FROM RTU SPRAY BOTTLES; STORE CAPS & SPRAY HEADS IN SEPARATE BAGS FOR RECYCLING

PET (code 1) RTU bottles and containers cannot be recycled and must be incinerated, but the HDPE or PP spray heads may be cleaned and recycled

IDENTIFICATION OF DIFFERENT TYPES OF PLASTIC (POLYMERS) USED FOR PESTICIDE PACKAGING



Identification triangles



COEX HDPE-LDPE

- Polyethylene terephthalate (PET or PETE) and mixed plastic (other) pesticide bottles** are thin and firm (mostly 1 litre and RTUs)
- High density polyethylene (HDPE) pesticide containers** can be any colour and are general firm, but soft to the touch (different volumes)
- Polypropylene (PP) pesticide bags and tubs**, bags can be any colour (bags crumble easily if left in the sun) (large variety of sizes)
- Low density polyethylene (LDPE) bags** are clear and usually used as lining in paper or PP bags for granular or powdery pesticides

Containers normally have the identification triangle embossed underneath the containers while bags normally have the identification triangle printed on the bag

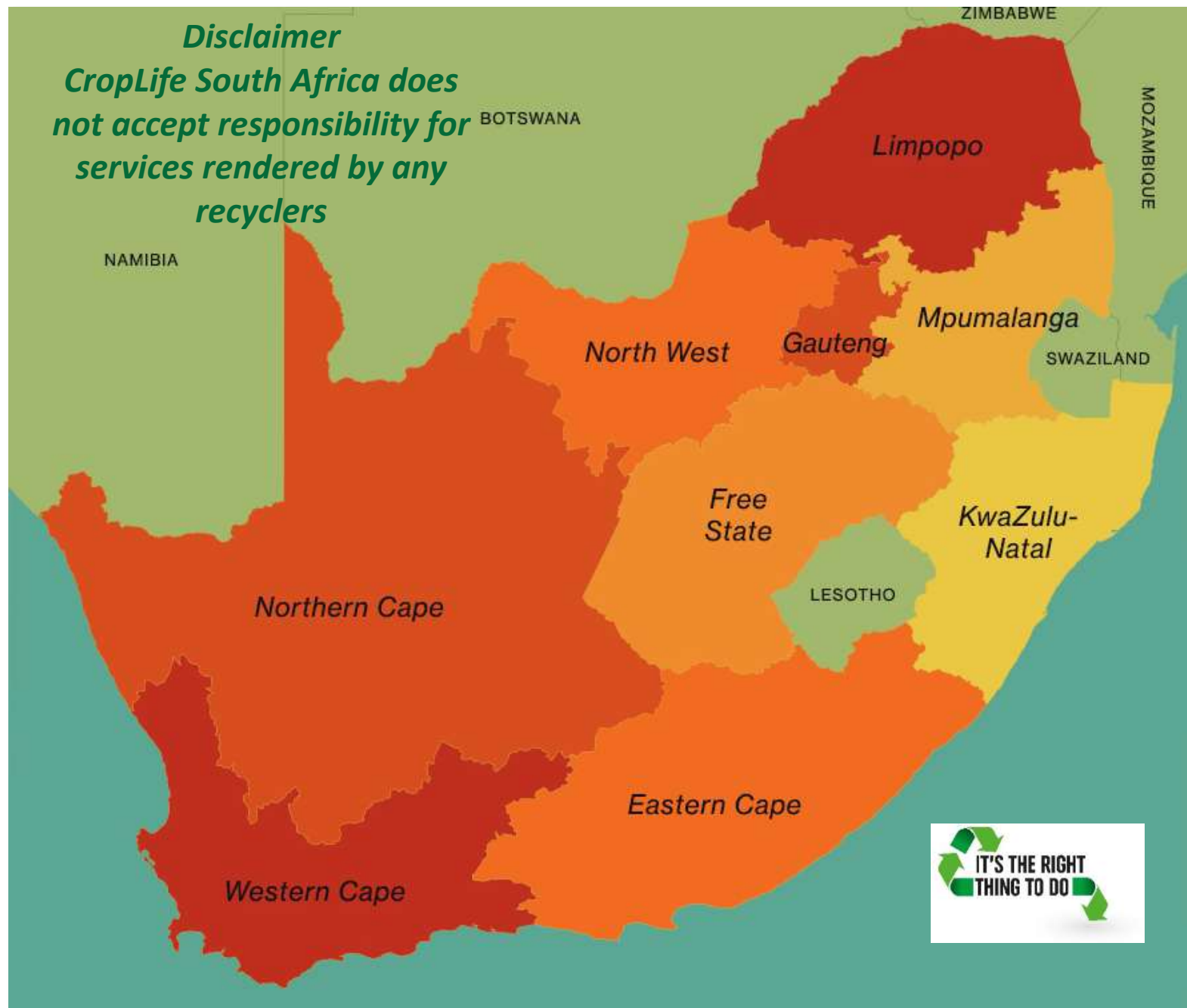
